## Market Movement

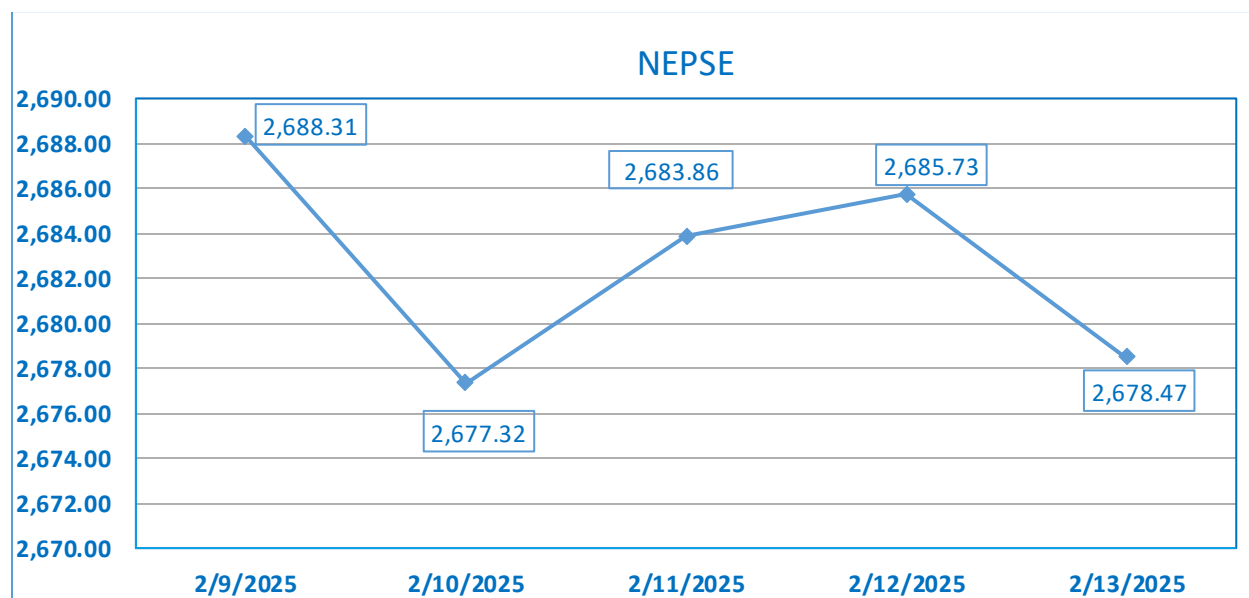


Figure 1: Market Movement for NEPSE index.

## Daily Turnover

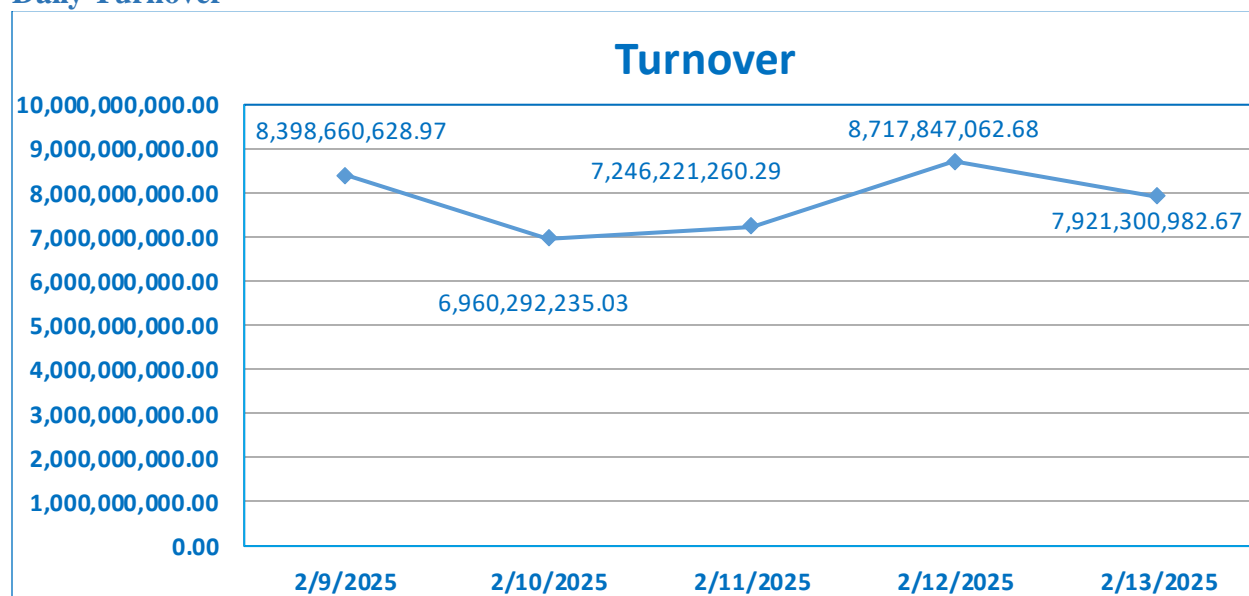


Figure 2: Turnover for NEPSE index.

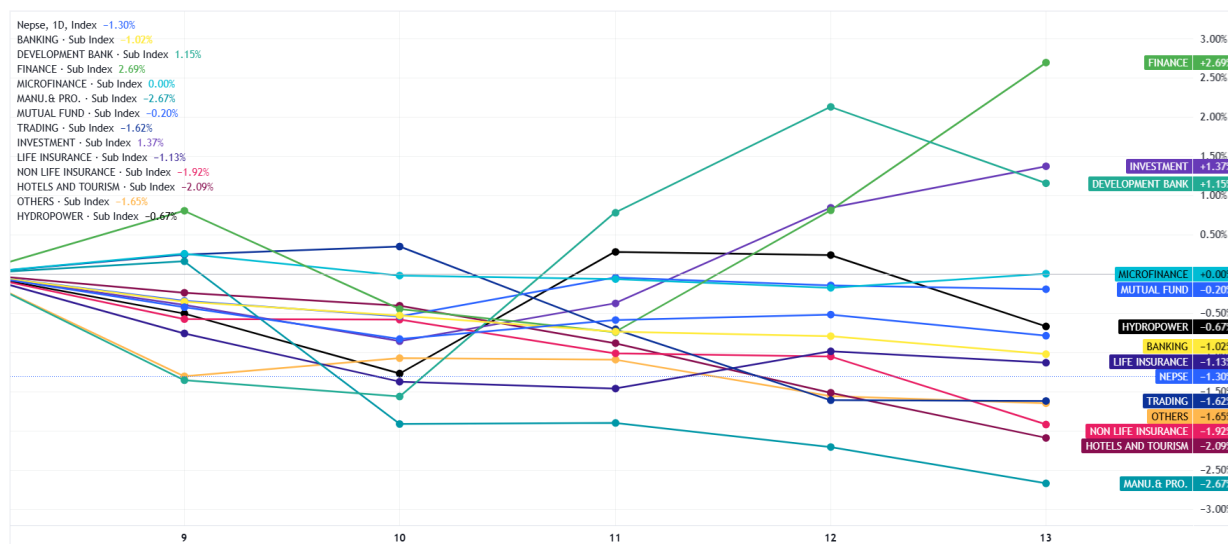


Figure 4: Daily sector movement relative to NEPSE index.

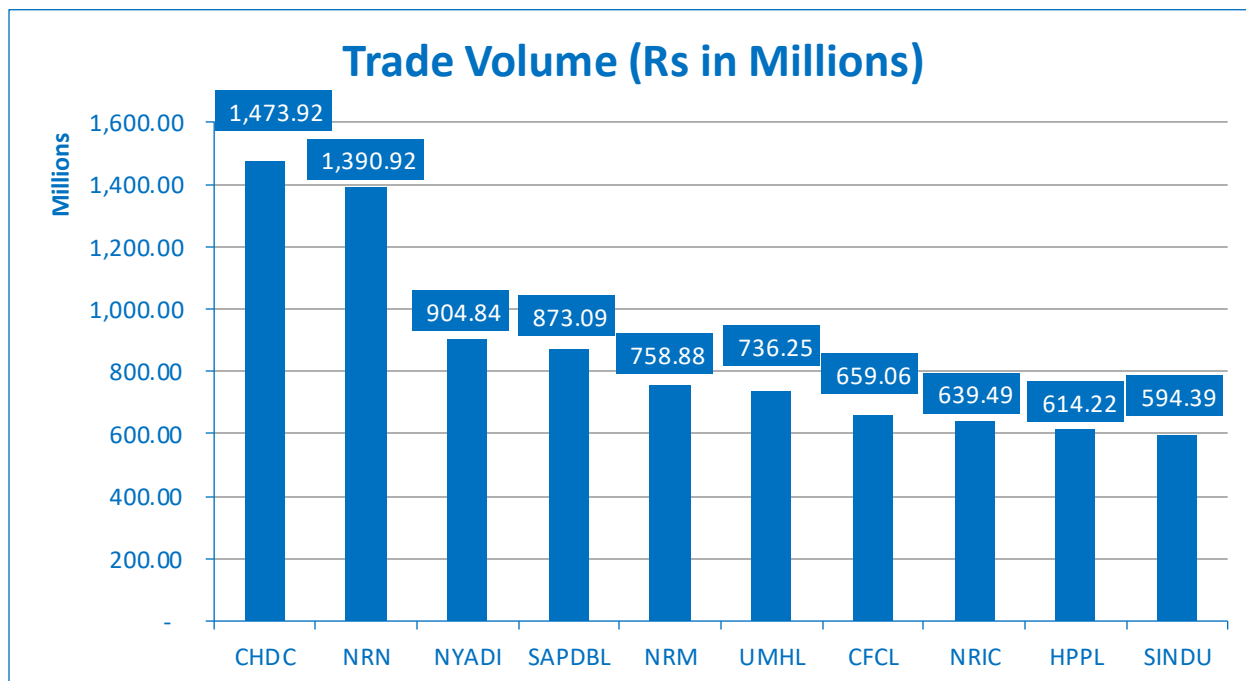


Figure 5: Top 10 Trade volume for the week.

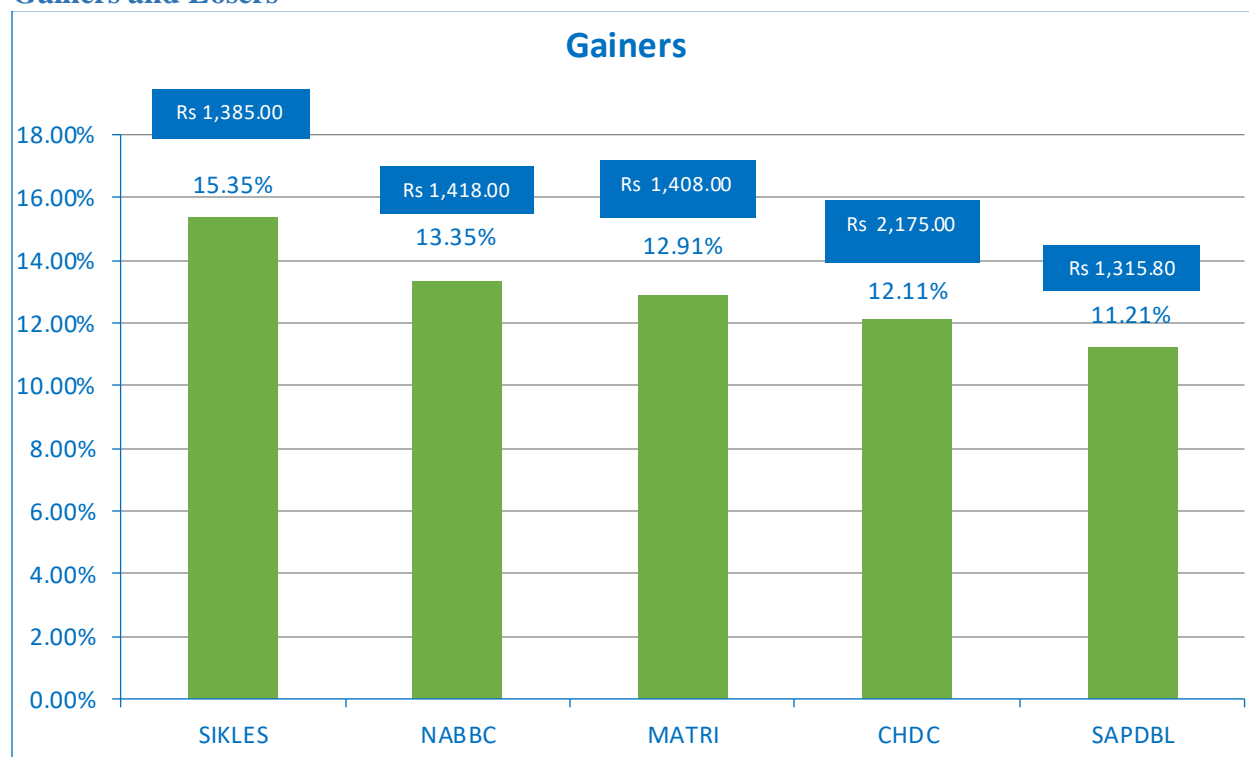


Figure 6: Top 5 Gainers for the week

## Technical Overview

From this weekly chart analysis, the Bollinger Band seems to be shrinking indicating an accumulation phase as the volume too seems to be increasing as the index rises by few points each weeks. The momentum from the last few weeks has been stopped by the minor resistance of 2700. However it's not a big deal since the market has to make its move before any trend is observed in the market. The DMI indicator does show chances of correction ending soon but has yet to show signs of strong trend as the black line in the indicator is below 20.
