

## Market Movement




Figure 1: Market Movement for NEPSE index.

## Daily Turnover




Figure 2: Turnover for NEPSE index.




Figure 4: Daily sector movement relative to NEPSE index.




Figure 5: Top 10 Trade volume for the week.




Figure 6: Top 5 Gainers for the week




Figure 7: Top 5 Losers for the week

The movement heading downwards continues. After weeks of selling, some buying has been observed as the index has reacted by making a support at the 2600 level. Yet again the index has breached lower making a lower low. Therefore, the trend is still bearish. Overall, we are still waiting for the correction to end and for a new rally to take place.

On daily graph,

The index has been and still is in a downward direction as it keeping on dipping lower making a new low time and again. The moment the short-term trend turns direction and heads upward breaking our downward trend line. We can expect the index to reach the highs of 2800s. until then the index has a higher chance of heading towards the major support area of 2400 where we had seen the market bounce back few months earlier.

From a bullish perspective until the index does make a new low which is below the 2400s. we can't consider the long-term trend as a downtrend. The correction was expected as the market headed from the 1800s to 3000 in no time.
