



## Market Movement



This week from 24<sup>th</sup> December to 28<sup>th</sup> December, with only 3 trading days NEPSE index dropped 40.20 points. The index closed at 2,068.90 generating negative weekly return of -1.91%. The average turnover has decreased by -11.32% to ~Rs 5.55 billion.



This week out of 13 sectors, only the non-life insurance and mutual fund index managed to stay green. As the market dropped -1.91% this week. While Most of the sectors were on a minor correction of 1-2%. Manufacturing & Processing, Investment, Trading gave a bigger fall of -3.35%, -4.68%, -6.98% each.


#### Daily sector wise movement of indices







## Technical Overview

After weeks of rally NEPSE index has stopped heading upwards. A relatively lower average volume has been observed for this week at 5.55 billion. The weekly candle for this week is a healthy candle as the market has managed to sustain near our recent top. We could be seeing more consolidation in this area before a rise towards the 2250 mark. The chances of NEPSE heading upwards is differently still higher unless we see the market falling below our major support areas in the near future.

In the upcoming days we expect the market to gain more strength and hopefully breach our previous resistance of 2250. We will most likely see less volatility in the market in upcoming days, as the index is now near its major resistance. With weekly return of -1.91% and average volume of 5.55 Arba NEPSE index marks its closing at 2068.90.

## Weekly analysis



\*One block is one week's price movement. Bigger the candle bigger the movement, **RED** for fall, and **GREEN** for rise

As we are heading towards the resistance area, the market has slowed down, showing symptoms of correction/ profit booking. Yet as the market has sustained relatively at our highs. We still have bullish momentum in the market. We can expect the market to still make a higher high, until and unless the market shows a clear signal for a huge fall in the upcoming days.

In short, the trend is an uptrend, with uptrend we naturally head higher and higher, unless the market breaks most of our major support area. Hopefully the market continues the trend and breaks above.

## Daily analysis



### In short:

With only 3 trading days this week, we didn't expect to market to rise higher, nor did we expect the market to fall hard. The market also did sustain this week, now we are looking for indications that might help us identify the market has finished its minor correction. Until then the market should keep on continuing its correction and slowly head towards our major support of 2020s.

Here are some of the zones to watch to determine the direction of the market.
