Market Movement

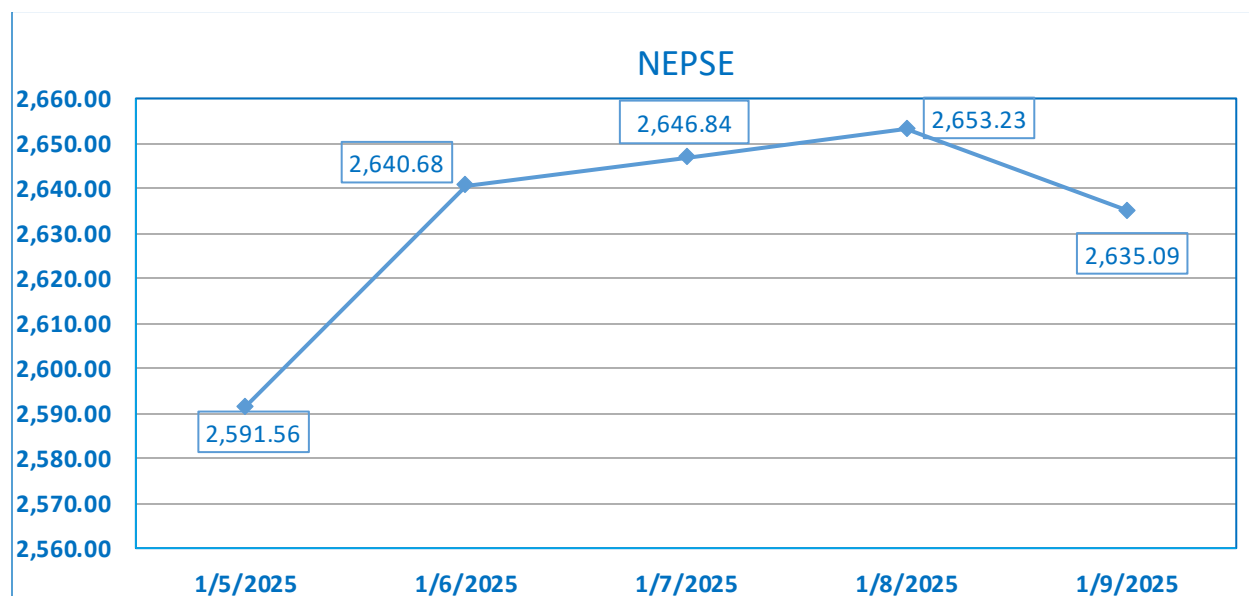


Figure 1: Market Movement for NEPSE index.

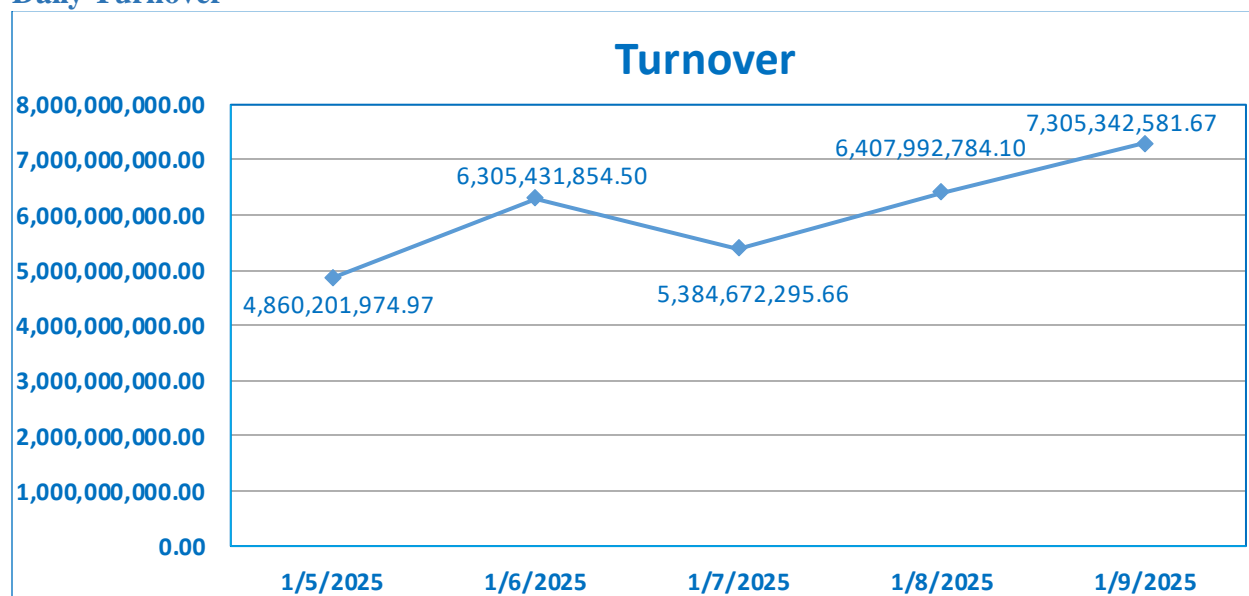


Figure 2: Turnover for NEPSE index.

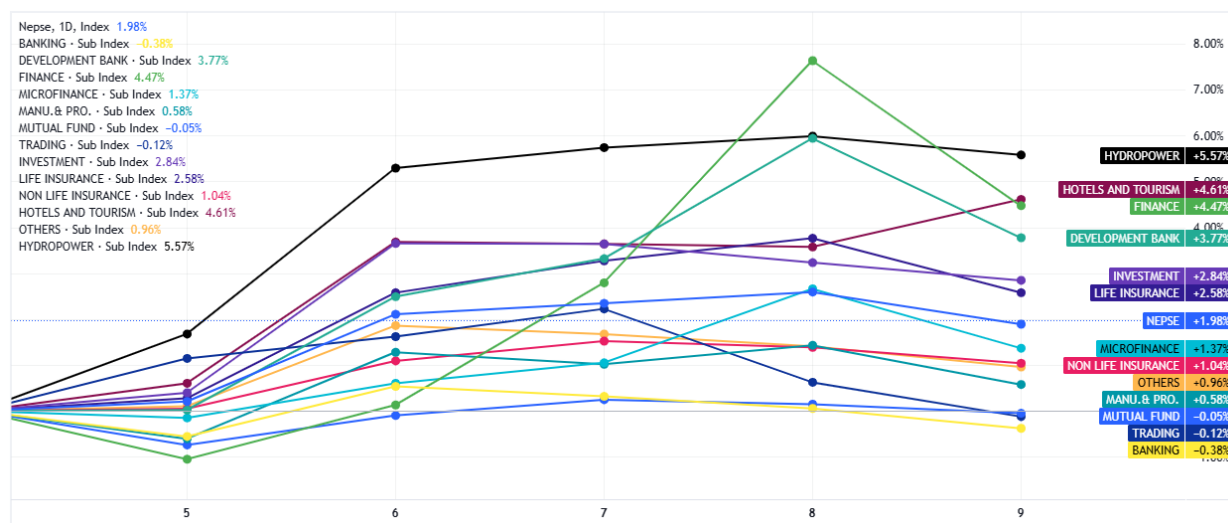


Figure 4: Daily sector movement relative to NEPSE index.

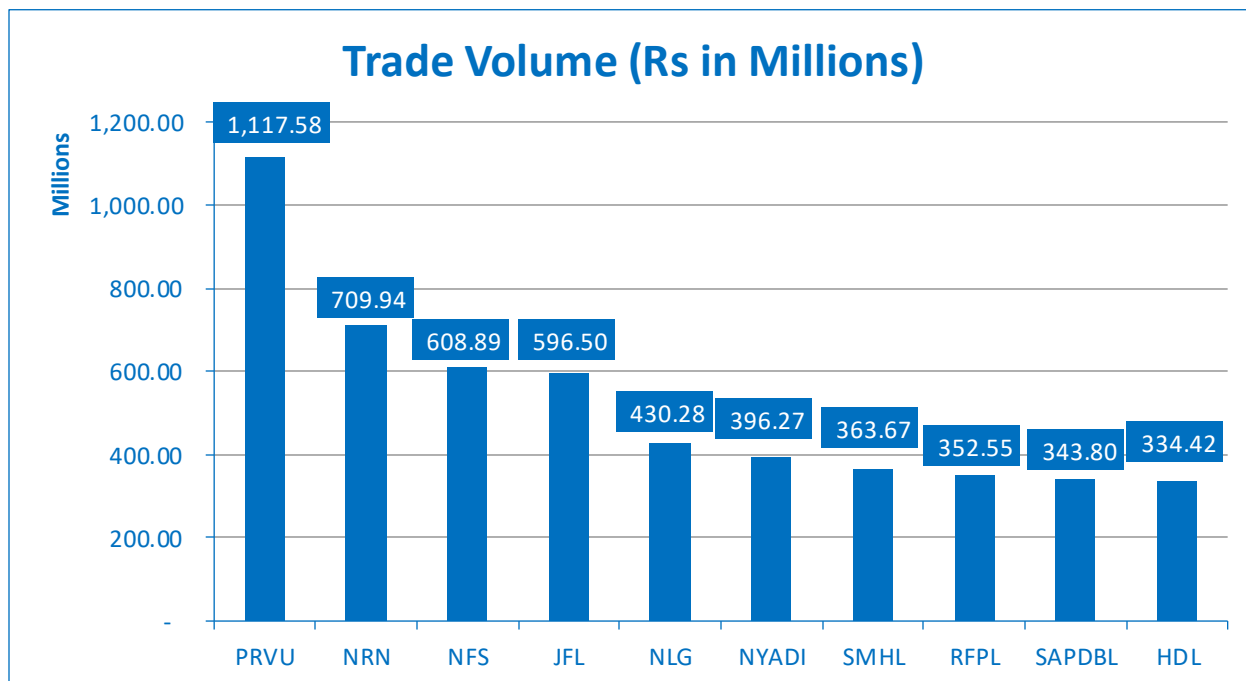


Figure 5: Top 10 Trade volume for the week.

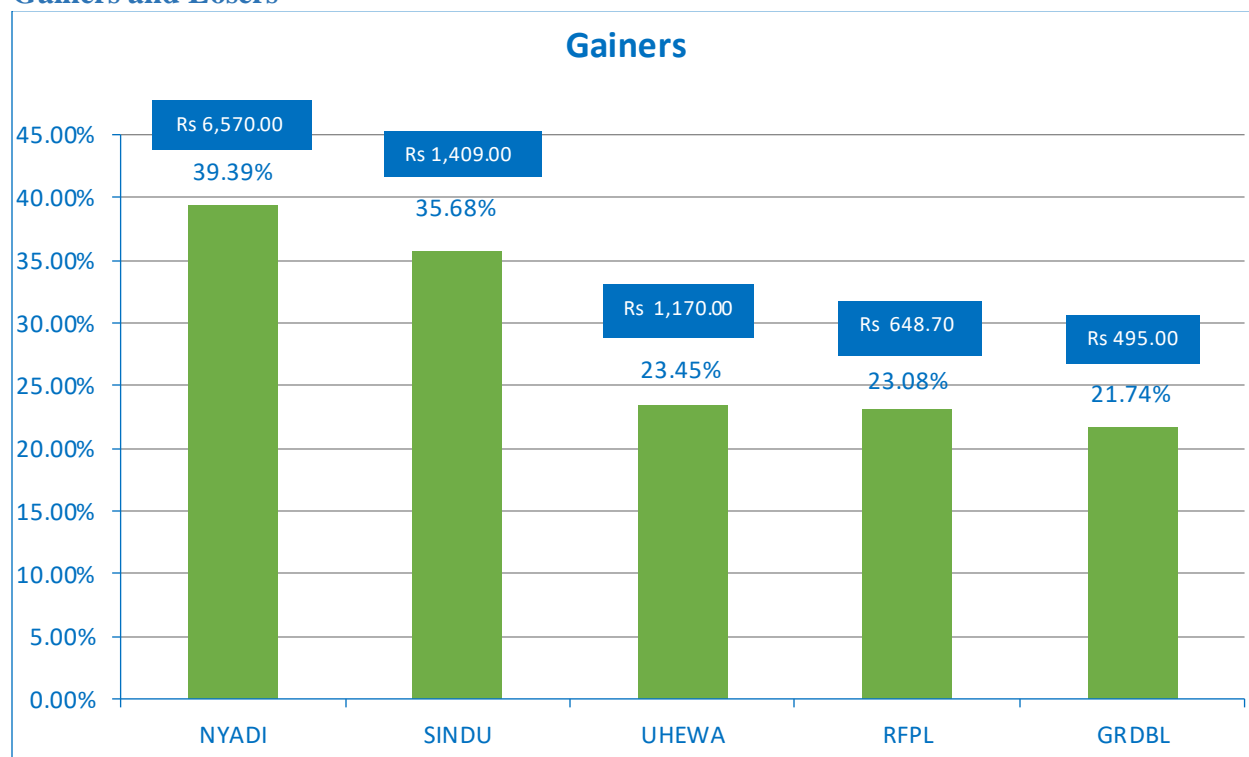


Figure 6: Top 5 Gainers for the week

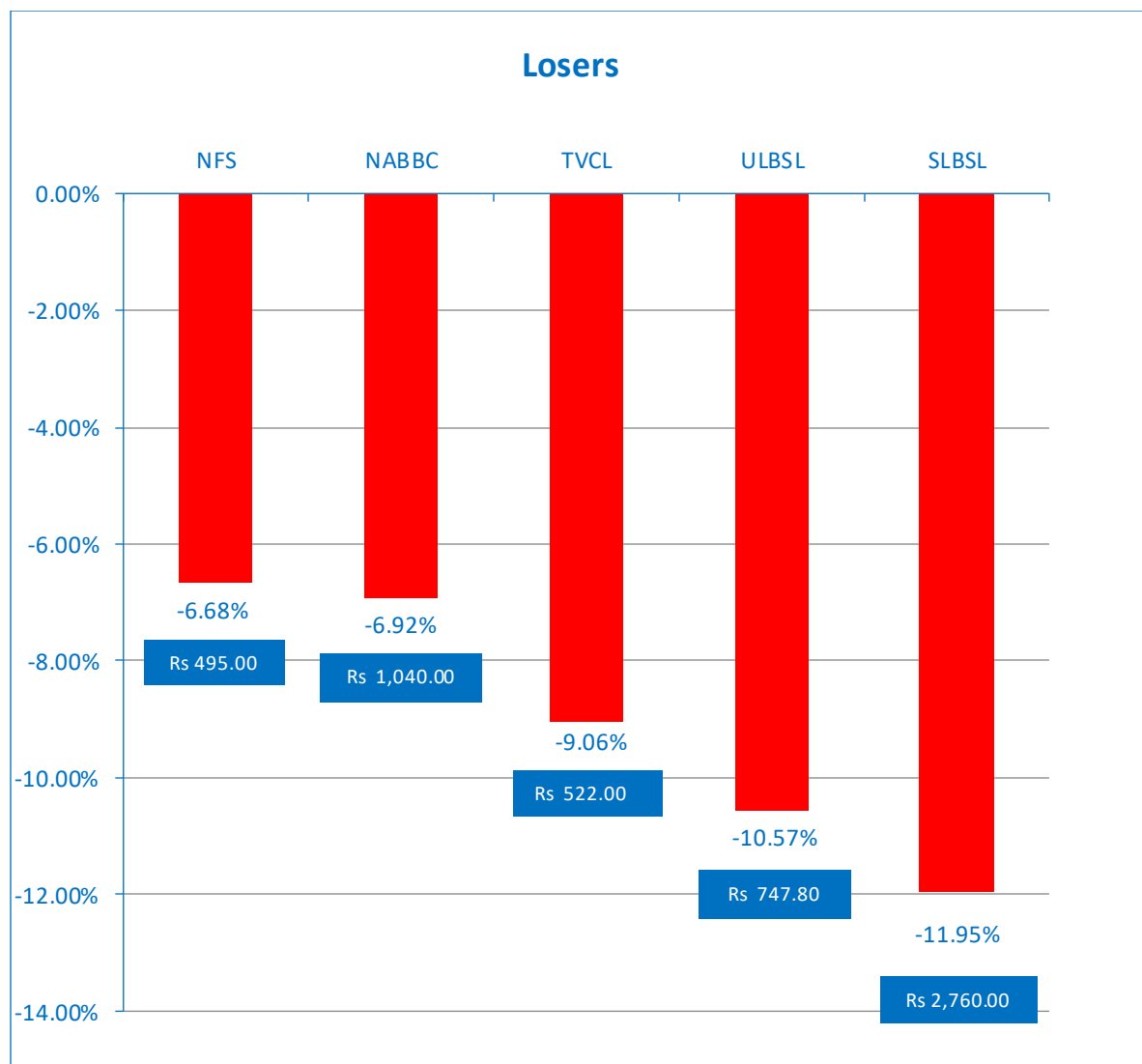


Figure 7: Top 5 Losers for the week

Technical Overview

As the market had shown bullish movement throughout the week. The market seems to hold above the 2600s. We have reached a weekly resistance area. The rise in volume supports the upward movement, which indicates the index's likeliness to head towards the 2800s in the upcoming weeks. However, looking into the weekly chart the indicators are yet to confirm the rise as the short-term trend has been active for the past few weeks. The red line above the candle signals bearish trend via the Super trend indicator. Followed by bearish signal in the MACD as well. Therefor the rise is rather a quick signal rather than a confirmation of the trend.

On daily graph,

Since the price action headed downwards through beyond the parallel channel. The market has been in a corrective wave. The index has recently reacted to the 2600s, bringing in some buyers into the market. And technically the market seems to be testing the “2680” Which was a failed support area some time ago. If the index shows weakness unable to breach the 2700s and further. The index is most likely to take some more time remaining sideways. Until further confirmation.

From a bullish perspective until the index does make a new low which is below the 2400s, we can’t consider the long-term trend as a downtrend. The correction was expected as the market headed from the 1800s to 3000 in no time.
